1. Call to Order.
2. Approve the minutes from the Regular Electric Utility Board Meeting on April 19, 2016.

Executive Session

3. Hold an executive session in accordance with V.T.C.A. Government Code §551.086 on the following competitive matters of Lubbock Power & Light:
 - a) Discuss and deliberate generation unit specific and portfolio fixed and variable costs, including forecasts of those costs, capital improvement plans for generation units, and generation unit operating characteristics and outage scheduling.
 - b) Discuss and deliberate proposals and strategies related to plans, studies, and analyses for system improvements, generation additions, or sales (other than transmission and distribution system improvements inside the service area for which LP&L is the sole certificated retail provider).
 - c) Discuss and deliberate bidding and pricing information for purchased power, generation and fuel, purchased power agreements, and related services and strategies.
 - d) Discuss and deliberate customer billing, contract, and usage information, electric power pricing information, system load characteristics, and electric power marketing analyses and strategies.
4. Hold an executive session in accordance with V.T.C.A. Government Code §551.071 seeking the advice of its legal counsel about pending or contemplated litigation or settlement offers and hold a consultation with the attorney on a matter in which the duty of the attorney to the Electric Utility Board under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas conflicts with Chapter 551 of the Texas Government Code ((i) Purchase Power Agreements; (ii) Distribution- Line Extension for Large Commercial Customer; (iii) Claims- November 3, 2015 Outage; (iv) Jaci Gibson and Juan Cuellar, Individually and as Parent and Next Friend of Minor Plaintiff Noah Cuellar v. Oscar Santos and the City of Lubbock, Cause No. 2016-520,289- 72nd District

Court; and (v) Jesus Martinez v. City of Lubbock and Jorge Romo, Cause No. 2016-520,480- 237th District Court).

5. Hold an executive session in accordance with V.T.C.A. Government Code §551.074 (a)(1) to deliberate the appointment, employment, evaluation, reassignment and duties of a public officer or employee (Director of Electric Utilities and General Counsel).

2:30 p.m. – Approximately - Following completion of the Executive Session, the Electric Utility Board will reconvene in open session to discuss the items listed below. It is anticipated that the open session will begin at 2:30 p.m. However, this is an approximation and the Board may begin the open session earlier or later depending on when the Executive Session is complete.

6. Public Comment – This period, of up to thirty minutes, is dedicated to citizen comments. Each citizen will have three minutes to speak. All comments must be limited to only those items posted on the Electric Utility Board agenda. Any citizen wishing to speak shall sign up on the citizen comment sheet on the day of the Electric Utility Board Meeting. The Electric Utility Board shall follow the order of citizens wishing to speak as listed on the sign-up sheet. If everyone who signed up to speak has been given an opportunity to speak and the thirty minutes designated for citizen comment has not been exhausted, the Electric Utility Board may, at its discretion, open the floor to anyone else wishing to address the Electric Utility Board, subject to all the same procedures and guidelines.
7. Expression of Appreciation for Service/Mayor and Ex-Officio Glen Robertson.
8. Presentation and discussion of the update/report by the Director of Electric Utilities, or his designee, regarding customer service, business center practices, procedures and policies, billing procedures, and LP&L staffing and performance.
9. Presentation and discussion of financial and capital statements, financing options, audits, and financial policies of Lubbock Power & Light relating to debt issuance issues, reserve account funding, cost allocation, and revenue and expense projections of Lubbock Power & Light.
10. Presentation and discussion of the FY2016-2017 Draft Operating Budget and Capital Program and Rate Schedule/Tariff.
11. Consider a resolution authorizing the Director of Electric Utilities to execute an Amendment to Professional Services Agreement, by and between Lubbock Power & Light and Hahn Public Communications, for professional services related to marketing campaigns, marketing social research and other communications related activities.

12. Receive a report and discuss underground utility locations and relocation activities and electric customer connections related to downtown redevelopment activities.
13. Discuss, deliberate and take minuted action regarding compensation and benefits of the Director of Electric Utilities and General Counsel.
14. Adjourn.
